Angling Code

I should like to see the following added in a paragraph following "Be aware of anglers..... As follows:

The angling season for trout, sea trout and salmon runs from the 3rd April to the 31st October, although there are some regional variations. During this period anglers may be wading in the river and casting long overhead lines, which may extend out behind the casting angler, who is likely to be facing downstream. Politely make such anglers aware of your approach and try to keep well clear.

It may also be wise to add something to the effect:

Anglers often fish with lures, which they cast across rivers and lakes. These lures may include an array of hooks, which are dangerous. If you swin into any fishing line be aware that the line will have hooks attached. Stop swimming, hold the line tightly and attract the attention of the angler to ensure he does not pull in the line whilst it is still attached or near to you
